INDUSTRIALIZED (MODULAR) HOMES (Up to two visits):

- \$ 80.00 – Single Family with up to 200 Amp Service – Plus Heat.

MANUFACTURED (MOBILE) HOMES (One visit):

- \$ 60.00 – Single Family with up to 200 Amp Service – Plus A/C if applicable.

BASEMENT OR INTERIOR RENOVATIONS, FLAT RATE (Up to two visits):

Residential Plan Review Deposit:

\$45.00 – The deposit is non-refundable but is applied to the permit fee when applicable.

Commercial Plan Review Deposit:

\$500.00 plus any additional review fees. If the review fee is less than the initial deposit of \$500.00, the remainder will be applied to the building permit fees or refunded to applicant. For projects where the cost would not exceed \$500.00 the plan review deposit may be waived.
